3. Privacy

Life Long Learning 4 Living keeps all personal data securely and confidentially in accordance with the Data Protection Act 2017, whether this is held on paper of electronically.

3.1. Personal Information we collect

We will store your personal information only if you choose to provide us with it, for example by completing a form on this site or speculative CVs. Any information you provide us with will be used only for the purpose which you have submitted it and will not be sold or passed on to third parties.

3.1.1. Website Visitors

Each time our website receives a visitor the company collects standard internet information as well as details of visitor behaviour patterns and this is done to help us identify the number of visitors to each part of the website. This data is depersonalised so that visitors cannot be identified.

The company also uses tools such as Google Analytics to help analyse the use of our website. This tool uses 'cookies' which are information text files stored on your computer to collect standard internet logs and visitor behaviour information. The information generated by this file, the 'cookie', includes your IP address and is transmitted to Google. The purpose for this is to evaluate visitor use of the website and to provide a statistical report for Life Long Learning 4 Living.



Life Long Learning 4 Living will not, nor will it allow a third party, to use any statistical information to or collect any information that makes visitors to our website personally identifiable. Google will not associate your IP address with any other data held by Google and neither shall they seek to link any personal identifiable information to your IP address.

3.1.2. Job Applications

When a job applicant applies to work at Life Long Learning 4 Living, we will only use the information supplied to us to process the application and to monitor recruitment statistics. A 'disclosure' is obtained from the Disclosure and Barring Service (formally known as the Criminal Records Bureau) for all applicants. Recruitment statistics that are retained are depersonalised so individuals are not identifiable and recruitment materials for unsuccessful candidates as well as speculative CVs are retained for no longer than 6 months before being destroyed.
